ORDER:-

By this Order, I intend to dispose of an appeal filed by Mr. Sahibzada Muhammad of M/S Chiltan Ghee Mill (Ptv) Ltd against Election Commission of Chamber of Commerce and Industry, Quetta before the Regulator of Trade Organizations under Rule 18 of Trade Organizations Rules, 2013.

2. Brief facts of the appeal are that it was alleged by the appellant that nomination forms were not issued to him despite a direction given to the Chamber by the Office of Regulator of Trade Organizations. The appellant was duly elected as member of Executive Committee for the year 2013-2014 and was desirous of contesting for the election of President of Chamber of Commerce and Industry, Quetta.

3. In order to decide the appeal, notices of personal hearing fixed for 27-9-2013 were issued to Secretary General and Election Commission of Chamber of Commerce and Industry Quetta, Baluchistan. During the personal hearing held on the above said date, the appellant was given the opportunity to explain his position, however, the appellant submitted in writing that he wants to withdraw the appeal and he was no more interested to press the same. The written statement of the appellant was accepted by this forum and resultantly the appeal was disposed off due to non-prosecution.
