By this order, I intend to dispose of an appeal filed by Travel Agents Association of Pakistan (TAAP) and others under sub Section 2 of Section 21 of Trade Organizations Act, 2013.

- 2. Brief facts of the appeal are that during the election process of TAAP for the year 2013-14, different complaints were filed before the Regulator of Trade Organizations which, interalia, pertained to cancellation of membership of Mr. Saboor Malik of M/s. Green Hill Travels (Pvt) Ltd, Rawalpindi, Rana Abdul Ghafoor Khan of M/s. GFQ International, Islamabad, Mr. Raees Ahmed Siddiqui of M/s. Hermain Travels (Pvt) Ltd. Karachi, and Mr. Muhammad Kalamuddin of M/s. System Travels (Pvt) Ltd, Karachi. It had also been alleged in the aforementioned complaints that instead of conducting elections on all seats of Executive Committee of TAAP, elections were being conducted on 50% of the seats of Executive Committee. The Regulator of Trade Organizations, after hearing both the parties, passed the impugned Order-in-Original No.8/2013 dated 02-09-2013 wherein it was decided that:
 - i) Election process of the Association for the year 2013-14 completed so far is annulled with immediate effect and the election schedule issued vide Association's letter No. BF: 05/13/KHI/212 dated 05-07-2013 shall consequently have no value in the eyes of law.
 - ii) A new election schedule for 2013-14 shall be issued by the Association strictly in accordance with requirements of Rule 18 of Trade Organizations Rules, 2013. The Association shall however ensure that entire election process for the year 2013-14 is completed by or before 30th December, 2013.
 - iii) The appellants and the respondents shall provide names of five members each to office of the Regulator within two weeks of issuance of this order who shall be short listed to constitute 3-members Election Commission. The process of short listing in consultation with representatives of both groups shall be completed under the supervision of the Regulator of Trade Organizations or his nominee. In case of disagreement on names, the verdict of the Office of the Regulator shall be final.
 - iv) Till completion of the fresh election process, current Executive Committee and office bearers will remain intact.
- 3. In order to decide the above referred appeal, notices were issued to the parties to appear before this forum on 29-01-2014. However, counsel for the petitioners requested for an adjournment due to his engagement before the Supreme Court of Pakistan. The request was acceded to and matter was adjourned to 10-02-2014. Accordingly, both the parties appeared before the undersigned on 10-02-2014.

4. The counsel for the petitioners reiterated the stance taken in appeal by stating that the Regulator of Trade Organizations passed an order without taking into

consideration the relevant provision of Trade Organizations Act, 2013 and Trade

Organizations Rules, 2013. The incumbent Executive Committee took charge on

05-07-2013, therefore election could not be held on all the seats of the Executive

Committee.

5. The counsel for the respondents alleged that by virtue of clause (e) of sub

section 3 of section 14 of Trade Organizations Act, 2013, order passed by the Regulator

in election matters shall be considered as final and no appeal could be filed against it.

He also emphasized on sub-rules 9 and 13 of Rule 18 of Trade Organizations Rules,

2013 whereby the Regulator is the final forum of appeal in election matters.

ORDER

6. After hearing the parties at length, perusing the record and documentary

evidence relating to the appeal and also keeping in view the relevant provisions of law

and rules, Order-in-Original No.8/2013 dated 02-09-2013 passed by the Regulator of

Trade Organizations is upheld. The TAAP is hereby directed to implement the said

order in letter and sprit, immediately
