In compliance of the order of Honorable Islamabad High Court, Islamabad dated 20-12-2017 in Writ Petition No. 4212/2017 titled "All Pakistan Textile Mills Association" (APTMA) VS DGTO etc, hearing was held on the same date at 1:00 p.m. The Counsel for the petitioner Trade Organization-APTMA, referring to the Stay Order granted by Honorable Peshawar High Court, Peshawar in Writ Petition No. 724/2014 passed on 07-03-2014, contended that for renewal of license the Extra General Body Meeting (EGBM) of APTMA could not be convened to amend the Memorandum and Article of Association (M&AoA) so as to bring it in line with the provisions of the Trade Organizations Rules, 2013.

2. It is hereby ordered that both the respondents in Writ Petition No 724/2014 in Honourable Peshawar High Court, Peshawar i.e. APTMA & DGTO would jointly pursue the case for vacating the Stay Order or filing Intra Court Appeal and thereafter, the renewal of license of APTMA will be processed as per law.
