By this order the undersigned intends to dispose of an appeal filed by Secretary General Gujrat Chamber of Commerce and Industry (GtCCI) against the decision of Election Commission of FPCCI which excluded the nominations submitted by Secretary General of GtCCI. The case was fixed for hearing on 01-12-2020 which was attended by both sides.

2. The background of the case is that the Election Commission of FPCCI excluded nominations of Gujrat Chamber of Commerce and Industry on the basis of non provision of valid license or documents pertaining to renewal of the same.

#### **FINDINGS:-**

The application for renewal of license of Gujrat Chamber of Commerce and Industry was submitted within prescribed time frame as per Section 6(2) of TOA, 2013. The subject TO fulfilled the codal formalities for renewal and the license has been renewed by DGTO.

#### **ORDERS:-**

Arguments heard, record perused and the relevant provisions of law examined.

2. The instant appeal is allowed and the decision of Election Commission of FPCCI is set-aside with the directions to accept the nominations of Gujrat Chamber of Commerce and Industry and include in the final voters list of FPCCI as the license of GtCCI has been renewed.

2. The matter stands disposed of accordingly.
