By this order the undersigned intends to dispose of an appeal filed by Secretary General Pakistan Crop Protection Association against the decision of Election Commission FPCCI dated 23-11-2020. The case was fixed for hearing on 01-12-2020 which was attended by both sides.

2. The background of the case is that the Election Commission of FPCCI excluded nominations of Pakistan Crop Protection Association on the basis of non provision of valid license or documents pertaining to renewal of the same.

FINDINGS:-

The application for renewal of license of Pakistan Crop Protection Association was submitted within prescribed time frame as per Section 6(2) of Trade Organizations Act, 2013. The subject Trade Organization is in process for renewal of license with DGTO and is complying with the directions issued by the DGTO from time to time and in general has complied with the provisions of Trade Organizations Act, 2013 and Trade Organizations Rules, 2013.

ORDERS:-

Arguments heard, record perused and relevant provisions of law examined.

2. In light of the above the instant appeal is allowed and the decision of Election Commission is set-aside with the directions to accept the nominations of Pakistan Crop Protection Association and include them in the final voters list of FPCCI.
3. The matter stands disposed of accordingly.
