**Date of issuance of Order:** 04-12-202

By this order the undersigned intends to dispose of an appeal filed by Mr. Mian Rehman Aziz nominee of Pakistan Steel Melters Association (PSMA) for the Election at Federation of Pakistan Chambers of Commerce and Industry (FPCCI) for the year 2021 against decision of election commission FPCCI against his exclusion from the provisional voters list for the year 2021. The case was fixed for hearing on 01-12-2020 which was attended by both sides.

2. The background of the case is that the appellants has been excluded from the Provisional voters list of FPCCI for the year 2021 by Election Commission on the grounds that he has not completed two years of valid membership with PSMA and was unable to provide documents including voters list/membership certificates to show that the nominee had completed two years as member of PSMA.

3. The Counsel for the Appellant that as per documents submitted to the Regulator, Mian Rehman Aziz has been a member of PSMA for the requisite period. Furthermore, the Counsel for the Appellant has submitted voters list showing name of Mian Rehman Aziz in the voters list.

4. The Counsel for the Respondent has submitted that the registered firm of Mr. Akram Farid, namely M/s Rehman Steel Furnace (Pvt) Ltd is not mentioned in the voters list.

#### **FINDINGS:-**


As per documents submitted, the name of Mian Rehman Aziz and his business concern indicate that he is a valid voter in the upcoming FPCCI elections 2021.

#### **ORDERS:-**

Arguments heard, record perused and relevant provisions of law examined, in light of the above, the following orders are passed:

- i) Instant appeal is allowed and decision of election commission FPCCI is set-aside.
- ii) The matter stands disposed of accordingly.
