By this order the undersigned intends to dispose of various complaints filed by existing and prospective members of All Pakistan Bedsheets & Upholstery Manufacturers Association regarding non-renewal / grant of membership of the association.

### FINDINGS

The background of the matter is that this office received complaints by following members companies regarding difficulties faced in getting their membership licenses from the association. One of the complainant is the Vice Chairman of the association and it's claimed that the Secretary General is not renewing / granting membership to legitimate business concern despite fulfillment of all codal formalities laid down Rule 11 of the Trade Organizations Rules, 2013. The personal hearing of the matter was fixed on 12-8-2020 which was attended by both parties.

2. The counsel of the complainants has submitted documents that show that more than approximately 121 persons submitted their NTN's application and membership fee to the Secretary General of the association well before June 15 for grant/ renewal of membership of the association. However, the Secretary General returned the membership fee after final date and renewal of membership did not renew their membership. It is a fact that the Secretary General is bound to ensure that all membership applications submitted to his office are processed in timely manner. And if applicant to be rejected they must record the reason in writing and communicated of the applicant. It appears that for 121 members applicants this process has not been followed satisfactorily manner furthermore, the counsel of the complainants has also raised objection on the voters list of the association and highlighted 22 members whose NTN's status is inactive. In this matter the complainants to filled separate appeal with the DGTO, after obtaining the decision to Secretary General of the association.

3. The counsel for defendant has rightly argued that 22 petitioners cannot claim the right of membership for 121 members as per Rule 11(6) Trade Organizations Rules, 2013. Furthermore, it is clear that if members have fulfilled requirements mentioned in Rule 11 of Trade Organizations Rules, 2013 their membership cannot be denied without effective reasons.
