

**FINDINGS / Orders:-**

- i. The Secretary General MCCI and counsel on behalf of Election Commission (Respondents) appeared before the Regulator Trade Organizations for personal hearing but none of complainants / appellants appeared before the Regulator TOs. The case was called on 10:00 a.m. and recalled again after 30 minutes, no one appeared on behalf of petitioners.
- ii. Since it is an election matter and bound by time. The appeal is dismissed for non prosecution.
