By this order the undersigned intends to dispose of complaints in pursuance of directions of Lahore High Court, Lahore in Writ Petition No. 44986 of 2020 dated 23-09-2020 filed by Mr. Muhammad Jamil Ahmed & others against Regulator Trade Organizations & others, wherein Respondent No.1 was given directions to decide the petitioners' pending representations (Annexure-M) of the petition expeditiously and in accordance with law. The judgment is reproduced for ready reference:-

*The petitioners counsel submits that this petition be disposed of by giving directions to respondent No.1 to decide the petitioners' pending representation (Annexure-M) expeditiously and in accordance with law.*

*2. In view of the above noted request, Respondent no.1 is directed to decide the petitioners' above said representation, if pending, strictly in accordance with law; after affording opportunity of hearing to all concerned; and, through well-reasoned speaking order as expeditiously as possible preferably within a period of fortnight.*

*3. The petitioners are directed to appear before respondent No.1 on 30-09-2020.*

In the light of above directions of Lahore High Court, Lahore, the case was fixed for hearing on 30-09-2020, which was attended by both sides.


2. The complaints mentioned at (Annexure-M) in subject petition were received by the office of DGTO on 10<sup>th</sup> August, 2020. A hearing on the matter was fixed on 10-09-2020 and all the issues were decided vide previous DGTO orders No. 02/2017 dated 05-05-2017, 14/2017 dated 17-08-2017, 34/2018 dated 14-12-2018, 94/2019 dated 15-10-2019, 05/2020 dated 27-01-2020, 73/2020 dated 24-09-2020 and by the Honorable Secretary Commerce's order No. 01/2018 dated 14-02-2018. For that matter, an order No. 73/2020 dated 24-09-2020 was passed be implemented by newly formed Executive Committee within a month after elections.

### ORDER

Arguments heard and record/ evidence perused, the following orders are passed:

All orders of DGTO No. 02/2017 dated 05-05-2017, 14/2017 dated 17-08-2017, 34/2018 dated 14-12-2018, 94/2019 dated 5-10-2019, 05/2020 dated 27-01-2020, 73/2020 dated 24-09-2020 and by the Honorable Secretary Commerce's order No. 01/2018 dated 14-02-2018 are still in effect.

The Association is directed to strictly comply with all the orders and the Secretary General is directed to submit a compliance report within fifteen days.
