By this order the undersigned intends to dispose of an appeal filed by Haji Noor Sultan President and Secretary General of Chakwal Chamber of Commerce and Industry against the decision of Election Commission of Federation of Pakistan Chambers of Commerce and Industry (FPCCI). The appeal was fixed for personal hearing on 30-11-2020 which was attended by both sides.

2. The background of the case is that Chakwal Chamber of Commerce and Industry submitted duly authorized nomination papers for Mr. Qazi Muhammad Akbar for Executive Committee and Mr. Ch. Shahzad Sadaat for General Body for FPCCI elections 2021.

3. The Counsel for the Appellant submitted that due to clerical error the nomination papers for the respective classes were interchanged. Mr. Qazi Muhammad Akbar was to be a nominee for Executive Committee for FPCCI and Mr. Ch. Shahzad Saadat was to be a General Body nominee for FPCCI elections 2021.

4. The Secretary General Chakwal Chamber of Commerce and Industry vide email dated 14-11-2020 intimated this position to the Election Commission of FPCCI. During the course of hearing, the members of the Election Commission of FPCCI agreed that if duly authorized nomination with relevant corrections are submitted to FPCCI, the Election Commission will have no objection to include Mr. Qazi Muhammad Akbar for Executive Committee and Mr. Ch. Shahzad Sadaat for General Body FPCCI.

FINDINGS:-

The nominations for Executive Committee and General Body for FPCCI elections are to be duly authorized by the Executive Committee of the Trade Organization signed by the President and the Secretary General of that Trade Organization for onward submission to FPCCI. Therefore if FPCCI receives the documents duly authorized by the concerned before 6th December 2020, they may be considered acceptable accordingly.

ORDERS:-

Arguments heard, record perused and relevant provisions of law examined. In light of the above, the following order is passed:-

- i) The nominations of Qazi Muhammad Akbar as Executive Committee and Ch. Shahzad Sadaat for General Body for the FPCCI elections 2021 are acceptable in principle. The Election Commission of FPCCI is directed to include these nominations in the final voters list provided, duly authorized notification by Secretary General of Chakwal Chamber of Commerce and Industry to this effect is submitted to the FPCCI before 6th December, 2020.
- ii) The matter stands disposed of accordingly
