By this order the undersigned dispose of appeal filed by Ms. Shazia Parveen Secretary General of Women Chamber of Commerce and Industry Mardan Divison (WCCIMD) against the decision of Election Commission of Federation of Pakistan Chambers of Commerce and Industry (FPCCI). The case was fixed for hearing on 30-11-2020 which attended by both sides.

2. As per contention of FPCCI, the background of the case is that election commission of FPCCI received nomination papers from two individuals claiming as Secretary's General of WCCI Mardan Division. FPCCI sent email to DGTO regarding clarification on the status of the recognized Secretary General of WCCI Mardan. However, as no response was received from DGTO office, therefore the election commission FPCCI excluded both sets of nominations submitted by Ms. Shazia Parveen and Ms. Saba Gul, the rival claimants of Secretary General of WCCI Mardan Division.

FINDINGS:-

As per the record of DGTO and order in original No. 106-2019 dated 27-11-2019 passed by Regulator TOs in which it was determined that Ms. Shazia Parveen is the recognized Secretary General of WCCI Mardan Division, the nomination papers submitted by Ms. Shazia Parveen shall be recognized by the Election Commission of FPCCI.

ORDER:-

The record of DGTO recognizes Ms. Shazia Parveen as Secretary General of WCCI Mardan Divison. Hence the instant appeal is allowed and the order of Election Commission of FPCCI is set-aside with the directions to include the nominees submitted by Ms. Shazia Parveen, Secretary General, WCCI Mardan Division, in the voters list of FPCCI elections 2021.

2. The matter stands disposed of accordingly.
