By this order the undersigned intends to dispose of appeal filed by Secretary General Pakistan Cotton Ginners Association against the decision of Election Commission FPCCI dated 23-11-2020. The case was fixed for hearing on 30-11-2020 which was attended by both sides.

2. The background of the case is that the Election Commission of FPCCI excluded nominations of All Pakistan Cotton Ginners Association on the basis of non provision of valid license or documents pertaining to renewal of the same.

FINDINGS:-

The application for renewal of license of All Pakistan Cotton Ginners Association was submitted within prescribed time frame as per Section 6(2) of Trade Organizations Act, 2013. The subject TO fulfilled the codal formalities for renewal and the license has been renewed by DGTO.

ORDERS:-

Arguments heard, record perused and the relevant provisions of law examined. The instant appeal is allowed and the decision of Election Commission is set-aside with the directions to accept the nominations of All Pakistan Cotton Ginners Association and include in the voters list of FPCCI as the license of APCGA has been renewed.

2. The matter stands disposed of accordingly.
