By this order the undersigned intends to dispose of appeal filed by Mr. Gulzar Firoz nominee of Pakistan Tanners Association against the decision of Election Commission of FPCCI regarding inclusion of name of Mr. Mian Nasir Hayat Maggo nominee of Pakistan Chemicals and Dyes Merchants Association in the voter list of FPCCI for the elections 2021. The case was fixed for hearing on 30-11-2020 which was attended both sides.

2. The background of the case is that appellants alleged that Mr. Mian Nasir Hayat Maggo is not eligible to be a nominee of All Pakistan Chemicals and Dyes Merchants Association on the basis that he did not qualify as a relevant business concern in the Association. The Election Commission declined the appeal and up-held the decision of Secretary General of FPCCI.

#### **FINDINGS:-**

The appellant has not provide any documentary proof to substantiate their claim that Mr. Nasir Hayat Magoo is not a relevant business concern in the Chemical and Dyes sector. Whereas, the counsel of the respondents submitted detailed documents that clearly indicate the respondents is a relevant business in the concerned sector. Therefore the decision of the Election Commission is liable to be up-held.

#### **ORDRS:-**

Arguments heard, record perused and the relevant provision of law examined in light of above the following orders are passed

1. The instant appeal is dismissed and the decision of Election Commission is up-held.
2. The matter stands disposed of accordingly.
